PAVERS FOR LANDSCAPING AND PATIO EXTENSIONS:

- Masonry edging must be ground level where it joins the grassed area of your yard so that the lawnmower wheels can ride on the edging as the lawn is mowed. This area should be outlined as a "clean" line to provide for easy maintenance. Your design should leave no areas of grass that will require special equipment to address.
- The color selected for this edging must be compatible with that of your home.
- The pavers/concrete should be placed to have a gradual slant away from the house such that water will drain away from the house into the yard.
- The space under the fence where the new patio adjoins it must be finished in such a manner that it requires no maintenance by the association's landscapers.

MULCHED AREAS:

- Expanded flower beds must be matching river rock or mulched. All river rock or mulch must be consistent in style and color to that used by the association's landscaper.
- It is your responsibility (and that of subsequent owners) to maintain these additional river rock or mulched areas. This will include maintenance of any additional river rock or mulch, weeding and the proper pruning or proper replacement of plants. If this area is not kept up to community standards you will be required to return it to its original condition.

PLEASE BE SURE THIS ADDITION CONFORMS WITH ANY REQUIREMENTS SET FORTH BY THE TOWN OF SCHERERVILLE, COUNTY, STATE ETC. AND THAT ANY NECESSARY PERMITS HAVE BEEN OBTAINED PRIOR TO INSTALLATION.
